AN OPPORTUNITY TO HELP REBUILD A NEIGHBORHOOD

This last summer, I spent several visits with Mayor Greg Sparrow of DeKalb discussing the potential of the DeKalb East Side Revitalization Project. We have an opportunity here to do something that many communities never get: We can actually design out crime and make a blighted area one of the most desirable areas of the city in which to live.

Several years ago, other communities also had this opportunity. Some, such as Sarasota, Fla., and Oakville, Ontario, chose to go the route of CPTED. Many chose not to do this, but later rethought and then tried to implement it.

CPTED (pronounced sep-ted) stands for Crime Prevention Through Environmental Design. It is based upon the writings of several authors beginning in the late 1960s through today, authors such as Oscar Newman, Jane Jacobs and Clarence Ray Jeffries, to name a few.

CPTED relies upon five basic principles, many of which can be implemented at the planning stage at little or even no cost. The outcome can be a more controllable and desirable area. The concepts Property Maintenance, Order Maintenance, Territorial

Reinforcement (and Boundaries), Natural Surveillance (including lines of sight) and Natural Access Controls are all part of the larger picture of CPTED.

I am a regular attendee at the CPTED Ontario conferences. Each year we hear more speakers who as city planners, architects, professors and police personnel have been involved in the successful implementation of CPTED principles in their respective areas. This organization's Web site is rife with information on this subject.

CPTED avoids the "fortressing" that many often associate with security, and many of my fellow members in the security, loss prevention and asset protection fields are still suspicious of it for this reason.

The greatest barrier, though, is always the acceptance by the community. Many of our neighborhoods in DeKalb have Neighborhood Watch. Individual residents in these areas show a desire to lower the risk of crime, but many have contraindicative security principles in use in the same neighborhoods, so we are watching for crime while we tacitly encourage it.

Such things as poor property maintenance encourage this.

For example, how many trees do we routinely pass by that extend branches closer to the ground than 6 to 8 feet? How many shrubs are higher than the recommended 32-inch height maximum for visibility? These alone disrupt lines of sight and, with foreseeability a hot topic in the loss prevention field, can actually place a property owner at a risk of liability. How many fellow residents ever actually call the 24-hour telephone number given by the city of DeKalb for reporting street light outages?

My point is this: We have a golden opportunity here to rebuild an entire section of the city to reduce the potential of crime, but the city cannot do it alone. It will need the cooperation of all of those who have a real interest in the future, a positive future, for DeKalb.
